# **Admission Requirements:**

In addition to the general university requirements, the following regulations shall apply to the admission of students into the department.

# **Direct Entry Requirement**

- i) Two 'A' Level passes in Economics or Accounting and an additional subsidiary subject. Candidates are expected to possess five credits at SSCE/GCE 'o' level and 'A' level must be attained at not more than two sittings or
- ii) A National Diploma Certificate from approved universities or colleges of technology or Polytechnics with a grade not lower than merit. In addition, the



applicant must possess five credits at SSCE/GCE 'O' level or its equivalent in subjects which include English language, Mathematics, and Economics Or

iii) Any credential approved by the senate of the University.

The students who meet the above criteria of admission are required to submit their application along with a set of document copies listed below.

- A completed Application Form.
- Personal essay explaining his reasons for chosen to study at the University.
- Official transcripts from all colleges attended
- Two Letters of Recommendation.
- On page brief resume;
- Two passport size color photos (2"X2")
- TOFEL scores, if applicable (For student whose primary language is not English.)
- Nonrefundable application fee US \$100.00

Day-to-day operations of the Admission Department are handled by the Director of Admission of the University. The final approval of admissions is handled by the Admission Committee.
